DECISION Nº MINESUP/SG/DAUQ/SDEAC OF

To Launch the Competitive Entrance Examination into the Professional Bachelor's Degree Cycle In National Tourism Guidance, in Management of Tourism and Hotel Business Establishments and in Development and Touristic Management of Territories of the Department of Tourism and Hotel Business in the Faculty of Arts, Letters and Social Sciences of the University of Yaoundé 1, for the academic year 2020-2021.

# THE MINISTER OF STATE, MINISTER OF HIGHER EDUCATION,

Mindful of the Constitution;

Mindful of Law of n°2001/005 of 16 April 2001 on the orientation of Higher Education;

Mindful of Decree n°2018/190 of 02 March 2018 to amend and complete some provisions of Decree n°2011/408 of 09 December 2011 on the organization of the Government;

Mindful of Decree n°2011/410 of 09 December 2011 appoint members of Government;

Mindful of Decree n°2019/002 of 04 January 2019 to reshuffle the Government;

Mindful of Decree N°93/026 of 19 January 1993 creating Universities;

Mindful of Decree N°93/027 of 19 January 1993 to define provisions common to Universities, modified and completed by Decree n°2005/342 of 10 September 2005;

Mindful of Decree N°93/035 of 19 January 1993 to grant Special Status to the Higher Education Staff;

Mindful of Decree n°2012/433 of 01 October 2012 to organize the Ministry of Higher Education;

Mindful of Decree n°2015/398 of 15 September 2015 to appoint Rectors in some State Universities;

Mindful of Decree n° 2018/074 of 29 January 2018 appointing members of the administration of some State Universities;

Mindful of Order n° 20-00407//MINESUP/SG/DAUQ/SDEAC/SE of 26 may 2020 modifying the order n° 20-00106/MINESUP/SG/DAUQ/SDEAC/SE of 17 March 2020 setting dates for competitive entrance examinations for admission into Faculties and Schools of Cameroon State Universities and Schools under academic tutelage of the Ministry of Higher Education, for the 2020-2021 academic year;

On the proposal of the Rector of the University of Yaoundé 1;

#### **DECIDES:**

Article 1: A written and oral Competitive Entrance Examination into the Professional Bachelor's Degree Cycle In National Tourism guidance, in Management of tourism and hotel business establishments and in Development and touristic management of territories of the Department of Tourism and Hotel Business in the Faculty of Arts, Letters and Social Sciences of the University of Yaoundé 1, for the academic year 2020-2021, has been launched in the unique centre of Yaounde from 24<sup>th</sup> and 25<sup>th</sup> september 2020 for the written part and 30<sup>th</sup> september 2020 for the oral part.

The number of available places is as follows:

- National Tourism Guidance: 10 places;
- Management Tourism and Hotel Establishments: 30 places;
- Development and Touristic Management of Territories: 10 places.

## Article 2: Conditions to be fulfillled

. Appplicants may be:

1- Cameroonians of both sexes with a sound knowledge of english and french who are holders of either a DEUG in social sciences (anthropology, archaeology, geography, history, art history, sociology, etc.) or in languages (german, english, spanish, french, etc.) for the National Tourism Guidance specialization and Development and Touristic Management of Territories; or a BTS (HND) or a DEUG in hotel business, catering, tourism, economics, management, marketing, etc.) for the Management of Tourism and Hotel Business establishments specialization, as well as any other certificate recognized by the Ministry of Higher Education as an equivalent of the aforementioned certificates.

2- Foreigners who fulfilled the required academic conditions for admission into professional bachelor's degree cycle in Tourism and Hotel Business in the University of

Yaounde 1.

### Article 3: Applications files

Completed applications files should be deposited at the student's records office of the Faculty of Arts, Letters and Social Sciences (FALSS) of the University of Yaoundel latest by 22<sup>nd</sup> september 2020. They should imperatively comprise the following documents:

- an individual application form to be collected from the student's records office of FALSS or

downloaded from the website of MINESUP whose address is: www.minesup.gov.com;

- a written and stamped application;

- a certified true copy of the required certificates not more than 3 months old or a certified true copy of an attestation of level or the equivalent issued by the Ministry of Higher Education;

- a legalized extract of the birth certificate not more than 3 months old;

- an attestation of presentation of the original of the required certificates;
- transcripts of the first and second years of higher education certified by the head of the establishment;
- a school attendance testimonial or an attestation from the applicants employer;

- one medical certificate;

- two passport sides (4 × 4) photographs (affix one on the first page of the application files and write the name and first name at the back of the second):

- a self addressed stamped (a the current rate) envelope;

- the receipt showing payment of the sum of twenty thousand (20 000) CFA francs been registration fee for the competitive entrance examination issued FALSS'S services. Registration fee shall be non refundable.

### Article 4: The examination

The competitive entrance examination shall comprise the following papers:

1- General knowledge (duration: 3 hours, coefficient: 2)

2- English (duration: 3 hours, coefficient: 2)

3- French (duration: 3 hours, coefficient: 2)

4- An oral test (coefficient: 4) after the written papers.

### Article 5: Admission

1- Candidates shall be admitted into the Tourism and Hotel Business Professional Bachelor's Degree according to the number of available places to be competed for, provided they shall have obtained a general average of at least 10/20;

2- The final results shall be published by the Ministry of Higher Education, on the recommendation of an admission jury whose compositions shall be determined according to the regulations in force.

Article 6: The Rector of the University of Yaoundé 1, the Director of University Accreditation and Quality, and the Dean of The Faculty of Arts, Letters and Social Sciences of the University of Yaoundé 1 are, each in his capacity, in charge of the implementation of this decision that shall be registered and published wherever need be.
